1. Refer sub clause 1.2.1 of clause 1.2 regarding Request for Proposal on page no. 7 of the RFP which says "The Authority is now inviting proposals ("Proposal") from experienced, qualified and interested Firms for selection of a Technical Consultant Unit (the "Consultant"), who shall provide requisite technical and operational support to undertake 1.("Consultancy").

This clause shall be read as "The Authority is now inviting proposals ("Proposal") from experienced, qualified and interested Firms for selection of a Technical Support Unit (the "Consultant"), who shall provide requisite technical and operational support to undertake the Scope of Services as given in Schedule 1.("Consultancy") ". This change shall be considered as part of the RFP.

2. Refer S.No. (1) of table in sub clause 3.1.2 under column heading Evaluation Criteria of clause 3 regarding Criteria for Evaluation on page no. 24 which says "Substantial experience of PMU with Central Government Health Sector with a minimum consultancy fee of Rs 1 cr. per annum, in last 5 years"

This clause shall be read as Government / State Government Health Sector with a minimum consultancy fee of Rs 1 cr per annum, in last 5 years" This change shall be considered as part of the RFP.

3. Refer S.No. (1) of table in sub clause 2.4.3 under column heading Documents (point b) of clause 3 regarding Conditions of Eligibility on page no. 12 which says "Certificate by company secretary"

This clause shall be read as "Certificate by company secretary/ Chartered Accountant / Managing Director" This change shall be considered as part of the RFP.

4. Kindly refer Scope of work mentioned in clause 2.2 on page no. 9-10 and Term of Reference - Scope of work mentioned in Schedule 1 (3.1) of the RFP on page no. 30-31. This is to clarify that Scope of work mentioned in both aforesaid clauses of the RFP are to be considered.

5. Refer sub clause 5.2.2 of clause 3.2 (Term of the Consultancy and indicative deliverables) of Schedule-1 on page 31 of RFP which says "A review of the performance of the TSU shall be carried out at the end of the first year and the second shall be further extendable by a period of 1 (One) years on satisfactory delivery of Consultancy on mutually agreed terms."

This clause shall be read as "A review of the performance of the TSU shall be carried out at the end of every year and further extendable by a period of 1 (One) year on satisfactory delivery of Consultancy on mutually agreed terms. Maximum engagement duration of selected consultancy agency shall be 3 years." This change shall be considered as part of the RFP.

6. Refer Sub clause 1.3.2 of clause 1.3 RFP document of the RFP on page no. 7 which says "The Applicant shall deposit (on-line mode through RTGS¹) the RFP Document Fee of Rs 5000.00 (Rupees Five Thousand only) + GST as applicable (non-refundable) in favor of "Uttar Pradesh Swasthya Bima Kalyan Samiti" payable at Lucknow. Any Proposal not accompanied with RFP Document Fee will be summarily rejected by the Authority as being non-responsive and the Proposal of such Applicant shall not be evaluated further."

This clause shall be read as "The Applicant shall deposit (on-line mode through RTGS¹/ in the form of Banker's Cheque or Demand Draft from a Scheduled or Nationalised Bank) the RFP Document Fee of Rs 5000.00 (Rupees Five Thousand only) (non-refundable) in favor of "Uttar Pradesh Swasthya Bima Kalyan Samiti" payable at Lucknow. Copy of Proof of payment of Rs. 5,000 (Rupees Five Thousand only) towards cost of RFP Document Fee shall be provided in Technical proposal. Any Proposal not accompanied with RFP Document Fee and Proof of payment of RFP Document Fee will be summarily rejected by the Authority as being non-responsive and the Proposal of such Applicant shall not be evaluated further." This change shall be considered as part of the RFP.

7. Refer Point no. 2.15.2(h) of Clause 2.15 regarding Technical Proposal on page no. 17 which Says "Copy of Proof of payment of Rs. 5,000 (Rupees Five Thousand only) + GST as applicable towards cost of RFP Document Fee."

This clause shall be read as "Copy of Proof of payment of Rs. 5,000 (Rupees Five Thousand only) towards cost of RFP Document Fee.". This change shall be considered as part of the RFP.
